If you fail to appear in the Document verification on the schedule date, batch & time, your candidature will be treated as cancelled without any further notice.

3. You are requested to invariably bring all the Original Certificates & documents, as applicable as per eligibility condition(s) attached to the post(s) applied for, for producing the same before the Commission during the Document verification session, failing which, your candidature will be liable to be cancelled. The candidate seeking AGE-RELAXATION & RESERVATION etc. should invariably ensure that he/she is fulfilling all the Terms & Conditions pertains to their respective Caste/Community/Category as stated at Para-12 of the Notice of Phase VI/2018/Selection Posts Recruitment and may also ensure that they are able to produce the Original Documents during the Documents Verification, otherwise their claims for age-relaxation, reservation etc. shall be forfeited.

6. It may be noted that age relaxation clause admissible to the Central Government Civilian Employee (CGCE) is only applicable for Group-C posts of Phase VI/2018/Selection Posts advertisement. This is applicable in case you are claiming age relaxation as a Central Government Civilian Employee (CGCE)] in Group C posts only. 7. <u>No travelling or other expenses</u> will be paid by the Commission for attending the document verification.

9. Canvassing in any form will result in cancellation of your candidature.
