
3. It is requested that the 'VACANCY CIRCULAR' may be published in the edition of 2nd week of February, 2014 positively.

VACANCY CIRCULAR

Subject: Filling up the post of Accounts Officer on Deputation in the Staff Selection Commission(ER), Kolkata – Regarding

Services of suitable officers are required for filling up one post of Accounts Officer on deputation basis in the Staff Selection Commission (Eastern Region), Kolkata, as mentioned in Annexure-I. Pay of the aforementioned officer will be regulated in accordance with provisions as per the Department of Personnel & Training's O.M. No.No.6/8/2009-Estt.(Pay II) dated the 17th June, 2010 as amended from time to time.

2. Officers who volunteer for the post will not be permitted to withdraw their names later. Applications not accompanying by the requisite documents will not be considered.
3. Names of suitable officers who are willing and eligible for the post and who can be spared may be sent to the undersigned in the attached proforma (Annexure-II), in duplicate, within six weeks from the date of its publication in the Employment News along with their ACR/APAR dossiers and a certificate about the vigilance clearance. Applications received after the prescribed date or without ACR/APAR dossiers will not be entertained.
