Subject: Scrutiny Status of candidates in respect of recruitment of 01-UR vacancy for the post of Library Clerk (Binding) advertised vide Post Category No. ER16222 of Advt. No. Phase-X/2022/Selection Posts- reg.

In continuation to the result of Computer Based Examination for Phase-X/2022/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Library Clerk (Binding) in pursuance of Para 18.22 of the Notice of Phase-X/2022/Selection Posts, which is as under:

"In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called <u>only for one more time, at the discretion of the Commission</u> for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5."

2. Essential Qualification for the post of Library Clerk (Binding) [Post Category No. ER16222] is as follows:

- (i) Matriculation or equivalent from a recognized institution;
- (ii) A certificate in Library Science from a recognized institution; and
- (iii) 3 years" practical experience in binding work in a registered commercial firm recognized by government or in a government organisation
