In continuation to the result of Computer Based Examination for Phase-IX/2021/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Personal Assistant in pursuance of Para 17.22 of the Notice of Phase-IX/2021/Selection Posts, which are as under:
