(a) Essential Qualification (EQ) attached to post is as follows:

(i) Graduate from recognised University (ii) Degree in Librarianship or equivalent qualification of a recognised University/Institution (iii) Not less than 2 years experience of work in big library (iv) Language proficiency upto Matriculation or equivalent.

(b) The Crucial date for determining age-limit and possession of Essential Qualification (EQ)/ Experience is 01.01.2021. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 25.10.2021.
