In continuation to the result of Computer Based Examination for Phase-X/2022/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Technical Assistant in pursuance of Para 18.22 of the Notice of Phase-X/2022/Selection Posts, which is as under:

"In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called <u>only for one more time, at the discretion of the Commission</u> for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5."

- 2. Essential Qualification for the post of Technical Assistant [Post Category No. ER11122] is as follows:
  - (i) 12th pass from recognized Board or University;
  - (ii) Diploma in Veterinary Science or Animal Science or Animal Husbandry or Dairying from a recognized University or Institute
