In continuation to the result of Computer Based Examination for Phase-X/2022/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Pharmacist-cum-Clerk (Homeopathic) in pursuance of Para 18.22 of the Notice of Phase-X/2022/Selection Posts, which is as under:

"In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called only for one more time, at the discretion of the Commission for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5."

- Essential Qualification for the post of Pharmacist-cum-Clerk (Homeopathic) [Post Category No. ER12122] is as follows:
 - 12th class passed or equivalent with Physics, Chemistry or Biology from a recognized Board or University;
 - Diploma or Certificate course in Homoeopathic Pharmacy of at least one year duration from a (ii) recognized institution
