**Subject: Scrutiny Status of candidates in respect of recruitment of 01-SC vacancy for the post of Research Assistant advertised vide Post Category No. ER15822 of Advt. No. Phase-X/2022/Selection Posts- reg.**

In continuation to the result of Computer Based Examination for Phase-X/2022/Selection Posts, the Commission has shortlisted additional candidates for next stage of scrutiny process for the post of Research Assistant in pursuance of Para 18.22 of the Notice of Phase-X/2022/Selection Posts, which is as under:

“In case, during the stage of Scrutiny of documents/final Document Verification, the Commission observes that the vacancy(ies) for a particular category of post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called only for one more time, at the discretion of the Commission for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5.”

2. Essential Qualification for the post of Research Assistant [Post Category No. ER15822] is as follows:
  - (i) Master's degree in Geography or Geology or Applied Geology or Geoinformatics or Geographical Information System and Remote Sensing or Geomatics or Geospatial technology from a recognized University or institute and having studied Geography or Geology or Applied Geology as a subject in all the years at Bachelor's Degree Level;
  - (ii) At least one year experience in research or preparation of maps and geospatial technologies in a Government recognized research or teaching or scientific or cartographic or geographic institute or organization
3. On scrutiny of the hard copies of Applications along with supporting documents received from candidates declared provisionally qualified in the Computer Based Mode (CBM) of Examination for Phase-X/2022/Selection Posts for the post of Research Assistant in National Atlas & Thematic Mapping Organization on the basis of Essential Qualification and other relevant terms & conditions of recruitment as mentioned in the Advertisement Notice, preliminary scrutiny status of the candidates is attached at **ANNEXURE**. The list is purely provisional and subject to correction due to any genuine ground viz. clarification from User/Indenting Department, production of equivalence certificate, error in scrutiny/data etc.

Please note that candidates who have provisionally qualified in the CBM Examination but have failed to submit hard copies of their applications along with copies of certificates in support of their Age, EQ etc. within the stipulated date (19.06.2023) and such other candidates who have not qualified in CBM Examination but have submitted hard copies and requisite certificates, have not been considered for the captioned recruitment. Further, the experience certificates of those candidates, who did not fill the relevant column regarding work experience in their online Application Form, have not been considered in terms of para 9.5 of the Notification of the Examination.
