- (ii) *Class 10th pass or equivalent from recognized Board and possessing a license in the trade of electrician, wireman, telecommunication mechanic or wireless mechanic from recognized licensing authority established under any law for the time being in force and having five years experience in an Engineering concern registered under the Factories Act, 1948 (63 of 1948) or in any Government or Semi Government Organization*

- (iii) *Class 10th pass or equivalent from recognized Board and possessing Industrial Training Institute trade certificate in Automobile X-ray or Machine man or Mechanic with five years experience in an Engineering concern registered under the Factories Act, 1948 (63 of 1948) or in any Government or Semi Government Organization*
or
- (iv) *Class 10th pass or equivalent with five years experience in handling and operating distilled water plants or gas testing instrument or sampling machine or weather-o-mete or fadeometer or corrosion chamber or spray printing machine or testing equipments (Bacteriological Laboratory) experience in an Engineering concern registered under the Factories Act, 1948 (63 of 1948) or in any Government or Semi Government Organization.*

2. The Crucial date for determining of age-limit and possession of Essential Qualifications (EQs)/Experience will be **01.01.2024** and **18.03.2024** respectively. The Crucial date for claim of SC/ST/OBC/EWS/PwBD/ESM status and reservation, where not specified otherwise, will be the closing date for receipt of online applications *i.e.* **18.03.2024**.
