- (iii) Two years" experience in the field of Ayurvedic Pharmacist from any recognized Ayurvedic Dispensary or Hospital or Pharmacy or Wellness Centre

2. The Crucial date for determining of age-limit and possession of Essential Qualifications (EQs)/ Experience will be 01-01-2022 and 13.06.2022 respectively. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 13.06.2022.
