Essential Qualification (EQ) attached to post is as follows:

- (A) (i) *B.Sc (Hons) in Nursing from a recognized University or Institute, or Regular course in B.Sc Nursing from a recognized University or Institute, or Post Basic B.Sc Nursing from a recognised University or Institute;*  
(ii) *Registered as a Nurse or Nurse and Mid-wife (Registered Nurse or Registered Nurse and Registered Mid-wife) with State Nursing Council; OR*
- (B) (i) *Diploma in General Nursing Mid-wifery from a recognized Board or Council;*  
(ii) *Registered as a Nurse or Nurse and Mid-wife (Registered Nurse or Registered Nurse and Registered Mid-wife) from State Nursing Council; and*  
(iii) *One years" experience in minimum fifty bedded hospital after acquiring the educational qualification mentioned at B(i) above.*
2. The Crucial date for determining of age-limit and possession of Essential Qualifications (EQs)/ Experience will be 01-01-2022 and 13.06.2022 respectively. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 13.06.2022.
3. On scrutiny of the hard copies of Applications along with supporting documents received from candidates declared provisionally qualified in the Computer Based Mode (CBM) of Examination for Phase-X/2022/Selection Posts for the post of Nursing Officer on the basis of Essential Qualification and other relevant terms & conditions of recruitment as mentioned in the Advertisement Notice, preliminary scrutiny status of the candidates is attached at **ANNEXURE**.
