No. HQ-PPI03/4/2023-PP_1 (E file no. 3867) : The candidates may please refer to the Notice of Combined Higher Secondary (10+2) Level Examination, 2023 (CHSLE-2023) published by the Commission on its website on 09.05.2023. The Commission conducted the CHSLE-2023 (Tier-I) from 02.08.2023 to 17.08.2023 in the Computer Based Mode. The result of Tier-I was declared on 27.09.2023. Subsequently, Additional Result of CHSLE 2023 Tier-I was declared by the Commission on 12.12.2023. The Commission conducted the CHSLE-2023 (Tier-II) on 02.11.2023 in the Computer Based Mode. The Tier-II of additionally qualified candidates was conducted on 10.01.2024. The Commission *vide* Important Notice dated 13.01.2024 has also informed the candidates that the Commission would obtain Option-cum-Preference before the declaration of final result of aforesaid exam.

2. Before the declaration of final result, Option-cum-Preference(s) for post(s)/department(s) are required to be submitted by those candidates who have appeared in Tier-II examination. Accordingly, all candidates, who have appeared in Tier-II, are advised to submit their Option-cum-Preference for post(s)/ department(s) for CHSLE-2023 through their respective 'CANDIDATE LOGIN' on the website of SSC (Headquarters) i.e., https://ssc.nic.in,wherein a tab for submission of Option-cum-Preference(s) for post(s)/ department(s) will be activated which will remain active during the period from **13.02.2024 to 18.02.2024.**

3. Candidates may please note that the Option-cum-Preference(s) can be revised only during the aforesaid period and Option-cum-Preference(s) last submitted by the candidate will be treated as **FINAL**. Candidates who fail to exercise their Option-cum-Preference(s) during the aforesaid period, shall not be given any further opportunity in any circumstances for submission of their Option-cum-Preference(s) and such candidates will not be considered for inclusion in the final merit list/final selection. Therefore, the candidates who have appeared in Tier-II are required to mandatorily exercise their Option-cum-Preference(s) for consideration of their candidature in the final merit list/final selection in CHSLE-2023.

4. Persons with Benchmark Disabilities (**PwBDs**) candidates must ensure that they give preference only for those posts which are identified as suitable for their disabilities. Allocation of posts will be made as per the provisions of the Notice of Examination on the basis of 'merit-cum-preference of posts'. The candidature of a **PwBD** candidate will get cancelled by the User Department concerned if he/ she gets selected for a post that is not identified as suitable for his/ her disabilities.

5. It is reiterated that the candidates will not be provided any further opportunity for the exercise of Option-cum-Preference beyond the dates mentioned above. Any grievance received in this regard in any form like Post, Fax, Email, by hand, etc. shall not been entertained by the Commission and will be summarily rejected.
