The Staff Selection Commission, Eastern Region, informs all candidates of the Multi-Tasking (Non-Technical) Staff and Havaldar (CBIC & CBN) Examination, 2024, about the importance of maintaining the integrity and fairness of the examination process.

It has come to the notice that following candidates from the Eastern Region have submitted similar or identical photographs across multiple registration numbers. This raises serious concerns regarding potential impersonation and other unethical practices aimed at gaining an undue advantage in the selection process. The Commission has issued show cause memoranda to these candidates, for debarment from future examinations. - 2. **Integrity of the Examination**: The SSC is committed to ensuring a transparent and fair examination process for all candidates. Violations of fairness and integrity compromise this system and undermine the efforts of genuine candidates.
- 3. **Consequences of Misconduct**: Misconduct will result in cancellation and debarment from future SSC examinations as per the provisions of the notice.

The Commission advices all candidates to strictly adhere to the rules and regulations outlined in the examination notice. Any attempts to manipulate the system will be met with appropriate action to ensure fairness for all.
