- 4. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:
  - i. In the ratio of 1:30 for upto 5 vacancies for any category of posts
  - ii. In the ratio of 1:15 for more than 5 vacancies for any category posts subject to minimum 150 (subject to the availability of suitable candidates).
- 5. In accordance with the Advertisement Notice, all qualified candidates found clear at the Scrutiny Stage for a particular Post, were called for Document Verification.
- 6. In the event of tie in scores of candidates in the Computer Based Examination, such cases were resolved by applying following criteria, one after another, till the tie is resolved:
  - i. Total marks in Computer Based Examination.
  - ii. Marks in Part-A of Computer Based Examination.
  - iii. Marks in Part-B of Computer Based Examination.
  - iv. Date of Birth, with older candidates placed higher.
  - v. Alphabetical order of names (starting with first name)
