- Scores in the CBM Examination of those candidates who did not appear for the Document Verification or who did not fulfill all the Criteria as per the Notice of Recruitment, have not been considered.
- The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:
  - In the ratio of 1:20 for upto 5 vacancies for any category of posts
  - In the ratio of 1:10 for more than 5 vacancies for any category posts subject to ii. minimum 100 (subject to the availability of suitable candidates).
- As per Advertisement Notice, in case, during the stage of Scrutiny of documents/DV, the Commission observes that the vacancy(ies) for a particular category of Post(s) is/are not getting filled up completely, an additional number of candidates who have qualified in the Computer Based Examination, in the order of merit, shall be called ONLY FOR ONE MORE TIME, AT THE DISCRETION OF THE COMMISSION for filling up the number of vacancies not getting filled up, in the ratio of 1:20 for vacancies upto 5 and 1:10 for vacancies more than 5.
