- 2. Final Merit List has been prepared on the basis of Performance in Computer Based Mode (CBM) Examination held on 06th to 10th November, 2020 and 14th December, 2020 (in Bihar).
- 3. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:

i. In the ratio of 1:20 for upto 5 vacancies for any category of posts

- ii. In the ratio of 1:10 for more than 5 vacancies for any category posts subject to minimum 100 (subject to the availability of suitable candidates).
