4. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:
 - i. In the ratio of 1:30 for upto 5 vacancies for any category of posts
 - ii. In the ratio of 1:15 for more than 5 vacancies for any category posts subject to minimum 150 (subject to the availability of suitable candidates).
