4. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:

- In the ratio of 1:30 for upto 5 vacancies for any category of posts
- In the ratio of 1:15 for more than 5 vacancies for any category posts subject to minimum 150 (subject to the availability of suitable candidates).

5. In accordance with the Advertisement Notice, all qualified candidates found clear at the Scrutiny Stage for a particular Post, were called for Document Verification.

6. In the event of tie in scores of candidates in the Computer Based Examination, such cases were resolved by applying following criteria, one after another, till the tie is resolved:

- Marks in Part-B of Computer Based Examination.
- Date of Birth, with older candidates placed higher.
- Alphabetical order of names (starting with first name)
