(a) Essential Qualification (EQ) attached to post is as follows:

- (i) *Master's Degree in Physics or Master's Degree in Chemistry from a recognized University; OR*
- (ii) *Bachelor of Engineering or Bachelor of Technology in Chemical Engineering or Textile Technology or Rubber Technology or Plastic Engineering or Polymer and Rubber Technology or Chemical Technology from a recognized University or Institution with one year experience in the relevant field*

(b) The Crucial date for determining of age-limit and possession of Essential Qualification (EQs)/ Experience is 01-01-2020. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 20.03.2020.
