- (i) Master's Degree in Physics from a recognized University; **OR**
- (ii) Bachelor of Engineering or Bachelor of Technology in Electrical Engineering or Electrical and Electronic Engineering or Electronic and Telecommunication Engineering from a recognized University or Institution with one year experience in the relevant field

(b) The Crucial date for determining age-limit and possession of Essential Qualification (EQ)/ Experience is 01.01.2020. The Crucial date for claim of SC/ST/OBC/EWS/PwD status and reservation, where not specified otherwise, is 20.03.2020.
