2. Final Merit List has been prepared on the basis of Performance in Computer Based Mode (CBM) Examination for Matriculation Level posts under Phase-VI/2018/Selection Posts Recruitment held on 16<sup>th</sup>, 17<sup>th</sup> & 18<sup>th</sup> January, 2019.

3. Scores in the CBM Examination of those candidates who did not appear for the Document Verification or who did not fulfill all the Criteria as per the Notice of Recruitment, have not been considered.

4. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:

- In the ratio of 1:20 for upto 5 vacancies for any category of posts
- In the ratio of 1:10 for more than 5 vacancies for any category posts subject to minimum 100.

5. Candidates called for Document Verification in the ratio of 1:10 (vacancy: No of Eligible candidates) for a particular category of post subject to availability of eligible candidates.

6. In the event of tie in scores of candidates in the Computer Based Examination, such cases will be resolved by applying following criteria, one after another, till the tie is resolved:

- Total marks in Computer Based Examination.
- Marks in Part-A of Computer Based Examination.
- Marks in Part-B of Computer Based Examination.
- Date of Birth, with older candidates placed higher.
- Alphabetical order of names (starting with first name)
