- 3. Scores in the CBM Examination of those candidates who did not appeared for the Document Verification or who do not fulfilled all the Criteria as per the Notice of Recruitment, have not been considered.
- 4. The Commission called for hard copies of online applications along with supporting certificates/documents from qualified candidates of CBM Examination in the following ratio in accordance with the vacancies of the particular category of posts:
 - i. In the ratio of 1:20 for upto 5 vacancies for any category of posts
 - ii. In the ratio of 1:10 for more than 5 vacancies for any category posts subject to minimum
